## PRIORITY AREAS FOR CATCH UP FUNDING

#### Priority 1

Phonics catch up interventions for children in years 1 and 2

In September, the Year 2 children did a phonics assessment and 83% of them had scored lower than they did in February. Of those that didn't go back, only one of them improved as the other two children scored 0 - therefore it was impossible for them to score lower. They scored 0 again in September.

### Priority 2

Reading, writing and maths conferencing and interventions for children in Years 1 - 5

We feel that, when you consider the percentage of school time lost, our younger children have lost the greatest percentage. It could be argued that these children have more time to 'catch-up', but the learning lost at an earlier age is proven to be more challenging to 'catch-up' so we are targeting our younger children to plug gaps in their knowledge for reading, writing and maths.

### Priority 3

Mental health and wellbeing support for targeted pupils as a result of a tricky lockdown

Our children in Year 1 have had the toughest return to school - most of these children have found the return to a more formal curriculum really challenging. These children need support through a high quality PHSE curriculum as well as plenty of opportunity learning through play. CPD needs to be provided for the class teacher to realise this.

There are other targeted children across the school who would benefit from therapy sessions, counselling, or ELSA sessions that focus on their mental wellbeing, their emotions and/or their social behaviours. This will hopefully impact on their mental wellbeing and prepare them better to approach their learning.
